

SCHOOL - PARENT COMPACT

School Responsibilities:

1. **IntelliSchool will provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the student to meet the State's academic achievement standards as follows:**
 - *The instruction program is individualized and self-paced. Incoming students are tested in reading, math and language. Remediation is provided in those areas that students test below grade level. Each student has an orientation interview with the instructor and together they create an individualized course of study based on the student's transcript, pre-test scores and academic need. Student progress is closely monitored and a variety of instructional strategies are used. Students work in small groups for projects. Instructors teach one-on-one or in small groups, as needed. For character education, the class gathers in a large, community group to participate in discussions and activities*
 - *The spiral construction of the A+LS curriculum allows students to be placed in remedial courses at their instructional level with age appropriate material. The instructor can customize the course, based upon a pre-test that targets only the specific areas in which the student lacks skills. The student works through his course, getting one-on-one assistance as needed, and building the skills that will allow him to successfully complete high school courses*
2. **Hold parent-teacher conferences during which this compact will be discussed as it relates to the individual child's achievement.**
 - *Parent-Teacher conferences are offered at the end of each grading period.*
 - *Parents are also invited to contact the student's teacher at any other time for updates.*
3. **Provide parents with frequent reports on their children's progress.**
 - *Parents will be notified if student performance, productivity or attendance becomes an issue.*
4. **Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:**
 - *Students are in attendance Monday through Friday from 8:00am to 8:00pm.*
 - *Staff is available to meet with parents on a pre-scheduled basis or on a walk-in basis.*
 - *The Site Administrator will contact parents if there are any behavior issues which may interfere with academic gains.*
 - *The Site Secretary will contact parents if there are any unexcused absences.*
5. **Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:**
 - *Students are in attendance Monday through Friday from 8:00am to 8:00pm.*
 - *The school encourages parent involvement at any time during those hours.*
